Carcinogen, mutagenicity, Repro toxicity, resp sensitizer, target organ toxicity, aspiration toxicity



Irritant, skin sensitizer, acute toxicity, narcotic effects, resp tract irritant, haz to ozone layer





• 1. OSHA sets up Temporary Housing in your Parking Lot




 2. The Compliance Officer mutters, "This is unbelievable" each time they enter a new area.



 3. OSHA calls in a professional film crew to document conditions. The crew is from "60 Minutes"


